

HOW TO SELF-EXCLUDE FROM ALL BRITISH LICENSED CASINOS

BY ENROLING IN THE 'SENSE' SCHEME

There are two ways that you can apply to register with SENSE. Firstly, a casino manager will help you to complete a digital application form in person at a participating casino (Note: you do not need to enter the casino's gambling areas in order to do this). Alternatively, if you do not wish to visit a casino, or it is otherwise inconvenient to do so, you can complete the attached application form and send it via email to SENSE info@sensescheme.com. **When applying by email, you will need to include:**

1. The attached Application Form **fully completed and signed**. (See below regarding your acceptance of our Terms and Conditions and Privacy Policy which are required as part of the application process).
2. A recent digital, head and shoulders photograph of yourself, taken as either as a 'selfie' or other suitable close-up. **Note this is necessary so that participating casinos will recognise you. The photo must therefore be clear and an easily recognisable image of yourself with no-one else in the picture.** For example, it must not be blurred or taken too far away and you should not be wearing e.g., sunglasses, a hat or other head or facial obstruction (i.e. unless the item is worn for medical or religious reasons and you would always be wearing the same item(s) during any casino visit).
3. **Proof of identity** A scan, or close up photo, of a recognised form of government issued ID (e.g., a passport or driving licence) on which the necessary details (e.g., name and reference number) can be clearly read and the photo of you can be clearly matched to the one you have supplied, as above.
4. **Proof of Address** A scan or photo of a recent, valid utility or equivalent bill (gas, electricity, council tax etc), again where your details can be clearly read and compared to the Application Form.

Please note that, by applying to join SENSE, you are also agreeing to the SENSE Terms and Conditions and Privacy Policy (which can both be found on the www.senseselfexclusion.com website). You are therefore accepting that the primary responsibility for enforcing your self-exclusion is your own. Participating casinos will not be held liable for any matter whatsoever if you breach your self-exclusion and manage to enter / or play, by whatever means, whilst registered with SENSE. **Equally, you agree that any losses incurred by you during such a breach will not be re-imbursed and that any winnings will be withheld.**

Registration with SENSE is for **a minimum period of SIX MONTHS** and you cannot remove yourself from the scheme during that period. However, you may ask to extend or renew your exclusion at any time for up to a maximum of five years by completing an **Extension Request Form** in writing. The enrolment will otherwise remain in place unless, or until, you visit a casino and request in writing for it to be removed. To do so, you will need to speak in person to a casino manager. Once this conversation has taken place you will be removed from SENSE if you still wish to do so, but please note that all participating casinos individually reserve the right to refuse permission for you to enter or gamble on their premises.
